

AGRITOURISM PARTICIPATION RELEASE AND WAIVER OF LIABILITY

1. REQUIRED STATUTORY NOTICE OF INHERENT RISK

(Pursuant to Florida Statutes § 570.89)

WARNING

Under Florida law, an agritourism operator is not liable for injury or death of, or damage or loss to, a participant in an agritourism activity conducted at this agritourism location if such injury, death, damage, or loss results from the inherent risks of the agritourism activity. Inherent risks of agritourism activities include, among others, risks of injury inherent to land, equipment, and animals, as well as the potential for you to act in a negligent manner that may contribute to your injury, death, damage, or loss. You are assuming the risk of participating in this agritourism activity.

2. MINOR PARTICIPANT POLICY & GUARDIAN REQUIREMENT

- **Legal Guardian Requirement:** A waiver must be completed for participating minor child(ren). Adults who are not the legal guardian of an accompanying minor **cannot** sign on behalf of that child. Unaccompanied minors or minors without a waiver signed by their legal guardian will be denied entry to agritourism activities.

READ THIS FORM COMPLETELY AND CAREFULLY. YOU ARE AGREEING TO LET YOUR MINOR CHILD ENGAGE IN A POTENTIALLY DANGEROUS ACTIVITY. YOU ARE AGREEING THAT, EVEN IF Baca Family Farm USES REASONABLE CARE IN PROVIDING THIS ACTIVITY, THERE IS A CHANCE YOUR CHILD MAY BE SERIOUSLY INJURED OR KILLED BY PARTICIPATING IN THIS ACTIVITY BECAUSE THERE ARE CERTAIN DANGERS INHERENT IN THE ACTIVITY WHICH CANNOT BE AVOIDED OR ELIMINATED. BY SIGNING THIS FORM YOU ARE GIVING UP YOUR CHILD'S RIGHT AND YOUR RIGHT TO RECOVER FROM Baca Family Farm IN A LAWSUIT FOR ANY PERSONAL INJURY, INCLUDING DEATH, TO YOUR CHILD OR ANY PROPERTY DAMAGE THAT RESULTS FROM THE RISKS THAT ARE A NATURAL PART OF THE ACTIVITY. YOU HAVE THE RIGHT TO REFUSE TO SIGN THIS FORM, AND Baca Family Farm HAS THE RIGHT TO REFUSE TO LET YOUR CHILD PARTICIPATE IF YOU DO NOT SIGN THIS FORM.

3. ACKNOWLEDGMENT OF INHERENT RISKS & ASSUMPTION OF RISK

I understand that agritourism activities involve inherent risks associated with working agricultural land, including but not limited to uneven ground, sudden weather changes, interactions with farm animals, farm machinery, and natural water bodies. I voluntarily accept and assume all risks of injury, illness, damage, or death associated with my participation and the participation of any minor listed on this form.

4. SIGNATURE & ACKNOWLEDGMENT

By providing my signature below, I certify that:

1. I am at least 18 years of age and legally competent to sign this agreement.
2. I have read and understand the mandatory Florida statutory warning set forth above.
3. I am the legal guardian of any minor children included in this registration.
4. If I have invited a minor with a different legal guardian, their legal guardian filled out another copy of this form for their own child.
5. I understand that every participant in my group must have their own form filled out.
